Contract for Wedding Planning Services

Services: Eden Weddings agrees to provide the following services to the client:

- Unlimited telephone and email consultations
- Maine Marriage License instructions
- Recommendations for the following service providers as applicable: ceremony venue, inclement weather alternative location, ceremony officiant, wedding dinner location, photographer, florist, cake-baker, hair, make-up, massage, day spa services, transportation, before and after wedding activities.
- Vendor contract strategy and advice
- Preparation of wedding day timelines

Conditions:

- The Client is responsible for making payment directly to the service providers they select. Eden Weddings does not accept commissions or kickbacks from service providers. Eden Weddings must be notified by the client of any changes made between the client and service providers.
- Service providers accepted by the client are responsible for their own business practices. Eden Weddings does not assume responsibility for negligent acts, errors or omissions of such professionals. The client agrees to hold Eden Weddings harmless for any error, non-performance, or change made by any service provider. Each service provider contracts directly with the client.
- Eden Weddings assumes no responsibility for any food, beverages, floral arrangements, décor, or other items brought by anyone to the event prior to, during or after the event.
- Client agrees to indemnify, defend and hold harmless Eden Weddings and Judith Tardiff from any and all liability, costs, damages, and attorneys fees resulting from or relating to any claims in any way connected with this event, except to the

extent of any negligence or misconduct by Eden Weddings. This provision extends to any damages caused by the client or the clients' guests or attendees in connection with the event. This agreement shall be construed according to the laws of the State of Maine. The parties agree that exclusive jurisdiction and venue for all claims of breach of this agreement shall be in Hancock County, Maine, USA. Liability is limited to the fee paid.

- If Eden Weddings is unable to provide services under this agreement for reasons beyond their control including, but not limited to termination of the event by the client, for any reason including weather conditions, acts of God, acts of terrorism or war or government action, the client will not be entitled to any refund of consulting fees due under this agreement.

Terms:

- Eden Weddings agrees to provide the client with all services detailed below, for a base price of \$800 for a **destination wedding**. This base fee does not include a representative of Eden Weddings at either the ceremony or the reception. This service may be added on at an additional fee of \$400.
- Eden Weddings agrees to provide the client with all services detailed below, for a base price of \$500 for an **elopement**. For purposes of this agreement, an elopement is defined as an event involving the bride and groom alone, with no attendants or guests attending. This base price does include attendance at the ceremony only and services as a witness.
- A non-refundable retainer of 50% of the agreed fee is due with the signed agreement. The balance is due 30 days after the date the agreement is signed. In the event that this agreement is executed less than 30 days prior to the event, the entire fee shall be payable with the signed agreement.

Upon Eden Weddings' receipt of this signed agreement and retainer, a counter-signed copy will be returned to the client for their records. The signature of the client represents the client's full understanding and agreement to the terms and conditions of the contract.
